IN ADDITION, FAMILIES OF SEVERAL HANDICAPPED PEOPLE IN THE AREA ARE SUPPORTED WITH DELIVERIES OF DONATED FOOD AND HOUSEHOLD SUPPLIES AND WE ARE ACTIVELY SUPPORTING OTHER AGENCIES.
