THESE DONATIONS OF USED CLOTHING AND HOUSEHOLD SUPPLIES REPRESENT A LARGE PORTION OF THE IN-KIND DONATIONS BY THE OPERATION. IN ADDITION, FAMILIES OF SEVERAL HANDICAPPED PEOPLE IN THE AREA ARE SUPPORTED WITH DELIVERIES OF DONATED FOOD AND HOUSEHOLD SUPPLIES AND WE ARE ACTIVELY SUPPORTING OTHER AGENCIES.
